SPONSOR GROWTH (FEB 2021 INTAKE)

As of February 4th, 2021, six (6) sponsoring companies have signed a Training Agreement with ITQAN Institute for Trainees' Sponsorship. A total of three hundred thirty-one (331) new demand of trainees have been confirmed for the forthcoming 2nd Semester 2020/2021 Intake. Communication with other potential sponsors is still ongoing. ITQAN extended appreciation to Saudi Aramco for the continuous effort and support to encourage contractor

companies to sponsor trainees and help increase Saudization percentage for Inspectors. The number of sponsoring companies has been increasing every new



intake.

As of Feb 2021 Intake, the total number of sponsors reached 76, a 77% increase from October 2017 intake (43).

VIRTUAL JOB FAIR FOR THE SECOND SEMESTER 2020/2021 FEB 21 INTAKE

On February 7th to 11th, 2021, ITQAN held the virtual job fair for the Second Semester 2020/2021 February Intake. Selected sponsors conducted the face-to-face interview with applicants in ITQAN premises following MOH health & safety standards. Six (6) sponsors

have confirmed their demand for inspection graduates. Two (2) new sponsors have been added to the list of ITQAN sponsors bringing the total number to 76. I. The event resulted in the addition of 331 sponsored trainees as of the Feb 2021 startup.

ITQAN GRADUATION COHORT 10 (FEB 2021)

On March 7th, 2021, a total of one hundred fifty (150) trainees from eleven (11) sponsors have passed all the required examinations and have completed the two-year Inspection diploma program at ITQAN. The sponsors included Saudi Aramco, Velosi, CAT Group, Gulf Engineering House, and others. It is worth mentioning that these graduates will start the On-The-Job Training (OJT) program to complete their Job Tasks Standards (JTS). This graduation brings the total number of graduates from the institute to one thousand four hundred fifty-five (1455) trainees.



ITQAN TECHNICAL ADVISORY COMMITTEE (TAC) FORMATION



As part of ITQAN's continuous effort for quality improvement, ITQAN Technical Advisory Committee (TAC) has been created on April 1st, 2021. TAC was composed of ITQAN MD as the Chairman and members from International Training Provider, Saudi Aramco's / Industrial Training & Inspection Departments, and selected sponsoring companies. The objective of TAC is to recommend continuous improvement of ITOAN industrial and technical programs and execute a curriculum enhancement plan as recommended. It is expected that this initiative will increase engagement with technical specialization to ensure a greater understanding of engineering and inspection. Furthermore, this will also help ITQAN explore the possibility of adding new disciplines as required by the Inspection industry in the future.

ITQAN TRAINEES FULL RETURN READINESS PLAN & COVID-19 MEASURES

Due to the impact of COVID-19 pandemic, training delivery at ITQAN switched to Distance Learning (DL) mode using Google Meet, Google Classroom and Google Drive as a platform. For over a year of facing these unfortunate circumstances, trainees gradually returned back to the Campus to resume practical classes (Workshop-Based Training).
